# COLORADO WINE INDUSTRY DEVELOPMENT BOARD REGULAR MEETING MINUTES

#### Legislative and Regulatory matters

  - a. Doug Caskey provided an update on CWIDB Legislative proposal
    - i. Still moving forward.

- ii. Presented to CAVE and CAVE will wait until there is final language before taking a stance.
- b. Doug Caskey mentioned that the Wine Festival regulations have been approved.
  - i. Cassidee Shull mentioned the legal opinion from legislative legal services that contradicts the regulation.
  - ii. Don't know if the committee on legal services will take a look at the result.
  - iii. Doug mentioned that there was a list of festival permits posted by LED.
- c. Juliann Adams provided an update on the first LED Liquor Advisory Group meeting.
  - i. Went over priorities.
  - ii. Briefly mentioned grocery store bill.
  - iii. The advisory Group will meet on the first Thursday of the month which conflicts with CWIDB meetings.
- d. Doug Caskey mentioned the TTB rulemaking process
  - i. Trade Practices, comment deadline in March.
  - ii. Nutritional content labeling being required in Europe next year, possible in the U.S. down the road.
  - iii. Larry Oddo expressed interest in hosting an industry forum to get input on either topic from the industry.
